3. Further, it has been observed that in respect of Inspector cadre, Pr.CCITs/PDGITs/CCITs/DGITs office is a non-field posting however the PDITs/PCITs/DITs/CITs charges under respective Pr.CCITs/PDGITs/CCITs/DGITs may be Field/Non-Field posting as per respective T&P Policy for AGT.

3.1 However, it has been observed that the respective supervisory authorities in turn post Inspectors from Non-Field to Field charges or vice versa or Non-Field to Non-Field charges under their respective jurisdiction in complete disregard to transfer policy. Accordingly, I am directed to request the concerned Pr.CCITs/PDGITs/CCITs/DGITs that they should not further post any Inspector posted in any charge under their jurisdiction as Non-Field posting as per Policy for AGT 2021 by Pr. CCIT(CCA), Delhi to any other Non-Field/Field charge under their jurisdiction or vice versa. If there is a requirement to do so, due to any administrative reasons/urgency, the concerned Pr.CCITs/PDGITs/CCITs/DGITs should make a formal request to the Pr. CCIT(CCA), Delhi for the same.

4. Compliance of this Order shall be made by **22nd November, 2021** under intimation to this office. All the Officers In-charge (Hqrs)/DDOs are hereby directed to relieve the transferred officials **positively by 22nd November, 2021(A/N)**. In case of any failure in relieving the transferred officials [except those transferred from the office(s) of the Pr.CCIT, New Delhi], the transferred officials would stand deemed relieved for new place of posting **w.e.f. 22nd November, 2021(A/N)** and would not require any formal relieving order from any office and inevitably join their new place of posting on **23rd November, 2021(F/N)**. In case the transferred officials are on leave with reference to aforementioned relieving date, they would invariably join their new place of posting on the next working day of the expiry of their sanctioned leave.

5. The DDOs will transfer the Service Book & LPC of the transferred officials to their new charge by 30th November, 2021 and the salary for the month of December 2021 will be drawn from the DDO of their new place of posting only.

6. Any request for change of posting from any official under transfer shall be entertained only when the same is forwarded to this office through proper channel from the new palace of posting of the said official. No request for change of posting shall be considered before getting relieved from current charge and joining of new charge.

7. The Official under transfer to another building shall get their bio-metric attendance shifted to their new place of posting after joining it.

8. The Controlling Officers would ensure that the official(s) before being relieved submit his/her resume/self assessment to the concerned Reporting Officer.
