**Sh. The promotion order is provisional and is subject to any review DPC taking place for any contingency like change in number of vacancies, re-fixation of seniority, change in recruitment rules, change in eligibility of officials of any grade etc. and direction of any court/CBDT/DoPT/Directorate of HRD etc.

4. Upon promotion, the above-said official would continue to be posted in his present place of posting, till further orders.
