All the Officers In-charge (Hqrs)/DDOs are hereby directed to relieve the transferred officials positively by 09th February, 2023(A/N). In case of any failure in relieving the transferred officials [except those transferred from the office(s) of the PR.CCIT, New Delhi], the transferred officials would stand relieved for new place of posting w.e.f. <u>09<sup>th</sup> February</u>, <u>2023(A/N)</u> and would not require any formal relieving order from any office and inevitably join their new place of posting on 10th February, 2023(F/N).
