Subject : Inter Charge Transfer from Delhi Region to Bihar and Jharkhand Region in the cadres of ITI/TA/Sr TA/Steno/MTS – reg.

Kindly refer to O/o the Pr CCIT, Bihar & Jharkhand Region letter F. No PCCIT/Pat/Estt/10030/09/2019-20/6237 dated 15.02.2021 regarding ICT from Delhi to Bihar & Jharkhand Region (copy attached).

2. In this regard, I am directed to informed that ICT applications in the cadres of ITI, Sr TA, TA, Steno Gr-II and MTS have been rejected by Pr CCIT, Bihar & Jharkhand Region due to the withdrawal of ICT policy vide HRD, CBDT letter F. No HRD/CMD-1/108/1/2020-21/6406 dated 22.12.2020, which reads as under :-

"....in continuation of letter F. No HRD/CMD/104/07/2013-14(Pt File II)/7612 dated 12.02.2020 of the HRD, henceforth, no Inter Charge Transfer as per Board's letter. No A-2020/37/86-Ad-VII dated 14.05.1990 and subsequent relaxations/directions /advisories/ instructions/clarification issued from time to time in the matters shall be considered/effectuated by the CCAs"
