It is further submitted that the vigilance clearance should only be signed by the Competent Authority (i.e. his/her HOD) or by the designated officer/ITO (HQ) with the prior approval of the Competent Authority and send their vigilance clearances of all such listed officers who are due for confirmation latest by 10th May, 2022.
