2. Smt. Shilpa Dahiya, ITI is hereby stayed in PCIT Central 03 charge till **31.07.2024**, would stand relieved for new place of posting w.e.f. **31st July, 2024(A/N)** and would not require any formal relieving order from her office and inevitably join her new place of posting on **01st August, 2024(F/N)**. Further, Smt. Abhishek Garg (OH), ITI is hereby stayed in PCIT 12 charge till **31.10.2024**, would stand relieved for new place of posting w.e.f. **31st October, 2024(A/N)** and would not require any formal relieving order from his office and inevitably join his new place of posting on **01st November, 2024(F/N)**.

3. Further, the Transfer and Posting order of the Income Tax Inspectors at Sr. No. 58, 95, 151, 201, 247, 249, 251, 258, 276, 295, 314, 319, 322, 326, 342, 407, 419, 464, 563, 624, 626, 663 issued vide order no 90/NGO/2022-23 and circulated vide F. No. P-307/5/T&P/AGT/INSPECTORS/2024-25/1859 dated 01.05.2024 is hereby cancelled with immediate effect.

4. Compliance of this Order shall be made by **01st August, 2024** under intimation to this office. All the Officers In-charge (Hqrs)/DDOs are hereby directed to relieve the transferred officials **positively by 01st August, 2024(F/N)**. In case of any failure in relieving the transferred officials [except those transferred from the office(s) of the Pr.CCIT, New Delhi], the transferred officials would stand deemed relieved for new place of posting w.e.f. **01st August, 2024(A/N)** and would not require any formal relieving order from any office and inevitably join their new place of posting on **02nd August, 2024(F/N)**. In case the transferred officials are on leave with reference to aforementioned relieving date, they would invariably join their new place of posting on the next working day of the expiry of their sanctioned leave.

5. The DDOs will transfer the Service Book & LPC of the transferred officials to their new charge by **08th August, 2024(A/N)** and the salary for the month of August, 2024 will be drawn from the DDO of their new place of posting only.

6. All the representation received till date regarding the Transfer & Posting Order no 90/NGO/2024-25 dated 01-05-2024 stands disposed off. Accordingly, the ITIs who are not relieved till date in pursuance of Order no 90/NGO/2024-25 dated 01-05-2024 and other T&P orders of ITIs in 2024-25 would stand deemed relieved for new place of posting w.e.f. **01st August, 2024(A/N)** and would not require any formal relieving order from any office and inevitably join their new place of posting on **02nd August, 2024(F/N)**.

7. The Official under transfer to another building shall get their bio-metric attendance shifted to their new place of posting after joining it.

8. The Controlling Officers would ensure that the official(s) before being relieved submit his/her resume/self assessment to the concerned Reporting Officer.
