- 8. In this regard, it is pertinent to mention here that the office of the Pr. CCIT, Delhi has issued Order No. 1407/NGO circulated vide F. No. P-307/5/T&P/2021-22/17131 dated 04.03.2022 vide which three Inspectors were deputed for the purpose of conducting independent verifications as required by the Committee. These three Inspectors have conducted independent enquiries and have submitted their reports in the prescribed proforma in all the cases which could be considered for appointment on compassionate grounds for R. Y. 2020. The grading in already graded cases as approved by the previous Committees has been reascertained & updated as per the latest guidelines issued by DoPT/CBDT from time to time force and the latest enquiry reports submitted by designated Inspectors.
- 9. The details of each application/case are mentioned in respect of 75 eligible applicants for R.Y. 2020. Further, grading sheets in respect of above mentioned 58 applications/cases are enclosed as Annexure 'A'.

- 10. For the post of Tax Assistant, the applicants having Graduation / equivalent or higher qualification are to be considered.
- 11. On processing the applications/cases, the Committee has found that only 23 eligible applicants are possessing graduate/ equivalent or higher qualification and are eligible for the post of Tax Assistant. - 20. Further, the Committee discussed the cases where the applicant(s) is/are Widow for compassionate appointment in light of FAQ No. 36 of DoPT's O.M. dated 30.05.2013 which states as under:-

"the widow who does not fulfil educational requirement of a post is considered for compassionate appointment, she can be appointed only against a multi-tasking staff post provided the appointing authority is satisfied that she can satisfactorily perform duties of the post with the help of some on job training."

Therefore, the Committee has considered the application of Megha Rani (Widow) for the post of MTS.

- 23.
