Sub: Estt.-Non-Gazetted - Deemed Relieving of Officials of Income Tax -reg.

The Annual General Transfer(AGT-2022 & AGT- 2021)/ transfer & posting orders of the officials of Income Tax were issued vide order no 1082/NGO/2021-22 dated 29-10-2021, 1092/NGO/2021-22 dated 10-11-2021, 1128/NGO/2020-21 dated 12-11-2021, 1211/NGO/2021-22 dated 20-12-2021, 204/NGO/2022-23 dated 03-08-2022, 214/NGO/2022-23 dated 05-08-2022, 274/NGO/2022-23 dated 09-09-2022, 275/NGO/2022-23 dated 09-09-2022, 521/NGO/2022-23 dated 02-11-2022, 671/NGO/2022-23 dated 02-12-2022, 712/NGO/2022-23 dated 28-12-2022, 1097/NGO/2022-23 dated 01-02-2023, 1098/NGO/2022-23 dated 01-02-2023, 1109/NGO/2022-23 dated 03-02-2023 and 1131/NGO/2022-23 dated 17-02-2023.

- 2. Vide above said Orders, officials of Income Tax were transferred with direction to join new place of posting after getting relieved or deemed relieved. However, it is observed that the various officials of Income Tax who were transferred vide above mentioned orders have not been relieved from their charge and are still working in their previous charge. This has led to acute shortage of staff in various charges and is hampering the administrative work. Hence, it has been decided that there will be no revision of AGT Order done so far in any Cadre for FY 2023-24 and orders will only be considered/done on extreme compassionate/administrative grounds/reasons.
- 3. In view of above, all the representations received till date regarding above mentioned AGT orders stand disposed off. Further, the officials of Income Tax who have not been relieved till date in pursuance of above-mentioned orders including other amendment transfer & posting orders issued by this office in FY 2021-22 & FY 2022-23 would stand deemed relieved for new place of posting w.e.f. 16<sup>th</sup> November, 2023(A/N) and would not require any formal relieving order from any office and inevitably join their new place of posting on 17<sup>th</sup> November, 2023(F/N). Any representation with regard to above said order would be considered only when it is sent after joining the new charge and through proper channel only on extreme compassionate ground.
- 4. Further, all the concerned DDOs are directed to transfer the Service Book & LPC of the transferred officers to their new charge by 16<sup>th</sup> November, 2023 under intimation to this office and the salary for the month of November 2023 will be drawn from the DDO of their new place of posting only. Any failure to obey the directions of this office by stipulated date on the part of the DDO would be seen adversely by the competent authority and necessary disciplinary action would be initiated against each such DDO as per relevant provisions/rules of the Govt. of India.
- 5. In view of the above, all the competent authority are required to ensure the relieving of all the officials of Income Tax who have been transferred vide above said AGT orders for their new place(s) of posting and send the compliance report in this matter by 16<sup>th</sup> November, 2023 through email at delhi.dcit.hq.pers.ng@incometax.gov.in.
