3. Compliance of this Order shall be made by **02nd November, 2021** under intimation to this office. All the Officers In-charge (Hqrs)/DDOs are hereby directed to relieve the transferred officials **positively by 02nd November, 2021(A/N)**. In case of any failure in relieving the transferred officials, the transferred officials would stand deemed relieved for new place of posting **w.e.f. 02nd November, 2021(A/N)** and would not require any formal relieving order from any office and inevitably join their new place of posting on **03rd November, 2021 (F/N)**. In case the transferred officials are on leave with reference to aforementioned relieving date, they would invariably join their new place of posting on the next working day of the expiry of their sanctioned leave.

4. The DDOs will transfer the Service Book & LPC of the transferred officials to their new charge by 10th November, 2021 and the salary for the month of November, 2021 will be drawn from the DDO of their new place of posting only.
