2. Compliance of this Order shall be made by **15th November, 2021** under intimation to this office. All the Officers In-charge (Hqrs)/DDOs are hereby directed to relieve the transferred officials **positively by 15th November, 2021(A/N)**. In case of any failure in relieving the transferred officials, the transferred officials would stand deemed relieved for new place of posting **w.e.f. 15th November, 2021(A/N)** and would not require any formal relieving order from any office and inevitably join their new place of posting on **16th November, 2021 (F/N)**. In case the transferred officials are on leave with reference to aforementioned relieving date, they would invariably join their new place of posting on the next working day of the expiry of their sanctioned leave.
