The Competent Authority is pleased to grant Proforma Promotion to **Sh. - Further, this proforma promotion order shall not confer any right to the official for continued officiating or seniority or for regular promotion and shall be governed by the instructions of DoP&T as contained in OM No. 28036/8/87-Estt.(D) dated 30.03.1988 and instructions issued by Government from time to time.
